September 1, 2020 CMPF COVID-19 Bulletin:

To the Families of Residents and Supporters of CMP

The CMPF Board of Directors is pleased to advise that as of this writing, our Home remains FREE of COVID-19.

We are confident that this positive outcome is a direct result of the proactive precautions and protocols that were implemented at the outset of the Coronavirus pandemic outbreak in March 2020.

This excellent outcome thus far is also a result of our residents and their families following the rules and protocols implemented in March. We thank everyone for their cooperation in keeping our residents and staff safe and healthy.

In response to requests from residents and families, we are modifying some restrictions.

In response to the serious threat that COVID-19 still poses to the health and wellbeing of our senior citizens, we will continue to keep some restrictions intact.

The following are sustained and/or amended protocols effective immediately:

- MASKS will continue to be MANDATORY inside the BUILDING
- CMP will remain CLOSED to VISITORS
- RESIDENTS can visit with their families OUTSIDE
- RESIDENTS must physically distance at least 6-feet apart when meeting with family members.
- Agency Cleaning Services (fall cleaning) will resume on September 1st, 2020
- RESIDENTS are allowed ONLY ONE cleaning service visit per month
- RESIDENTS using the PSW service must use the cluster care method allowing for one PSW for the building, Monday to Friday
- Any RESIDENT who has been away from CMP overnight MUST FOLLOW STRICT QUARANTINE PROTOCOLS for 14-days immediately upon their return, in order to protect other residents.

With respect to potential NEW RESIDENTS, Zlatka and Dr. Chris Stefanovich will be reviewing all admission applications and medical forms.

Finally, restrictions, protocols and procedures will be re-evaluated at Thanksgiving (rules will be updated based on Public Health information) and any further amendments will be announced shortly thereafter.

The CMPF Board wants you to know that the health and wellbeing of our residents remains our #1 priority.

As always, we thank you and your families for your continued support of our Home, our residents, our staff and the CMP Foundation.
